2 December 28, 2013.

- 4 2. On September 30, 2009, Mohs plead guilty to, and was convicted of one charge  
5 of Conspiracy to Commit Aggravated Theft in the First Degree, a Class B Felony.  
6 This conviction was the result of Mohs having fraudulently written a life insurance  
7 policy on her father, after his death, for the benefit of her mother. On September  
8 29, 2009, Mohs' insurance producer license was revoked for the conduct  
9 involving the life insurance policy, and because of her failure to report her  
10 previous discipline by the Oregon Government Ethics Commission and the  
11 Teacher Standards and Practices Commission, pursuant to ORS 744.089. On  
12 May 21, 2007, the Commission suspended Mohs' license for 30 days for failure  
13 to follow Willamette Education Service District's policies, the Oregon Government  
14 Ethics Commission's standards and the Commission's standards.

15 **CONCLUSIONS OF LAW**

16 Nicolasa Mohs's conduct described above constitutes gross neglect of duty in  
17 violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-  
18 020-0010(5) (Use professional judgment); OAR 584-020-0040(4)(o) as it incorporates  
19 OAR 584-020-0035(3)(a) (Maintain dignity of profession by respecting and obeying the  
20 law, exemplifying personal integrity and honesty); and gross unfitness under ORS  
21 342.175(1)(c); OAR 584-020-0040(5)(c) (Conviction of violating any federal, state, or  
22 local law. A conviction includes any final judgment of conviction by a court whether as  
23 the result of guilty plea, no contest plea or any other means). The Commission's  
24 authority to impose discipline in this matter is based upon ORS 342.175.

18 OF ORS 183.482 TO THE OREGON COURT OF APPEALS.


