6 **STIPULATION OF FACTS**

7 1. Mr. Nelson has been licensed by the Commission since August 24, 1998. Mr. Nelson  
8 holds a Standard Teaching License issued July 15, 2002, valid through March 5, 2008, with  
9 Basic Mathematics and Standard Music Endorsements.

10 2. On July 17, 2000 the Commission imposed a 90 day suspension and two year  
11 probation upon Mr. Nelson's licensure for accessing inappropriate web sites.


12 3. On September 11, 2006, the Greater Albany School District reported that Mr. Nelson  
13 used district equipment to access inappropriate web sites.

14 4. Mr. Nelson fully cooperated with the Commission's investigation into this report and  
15 voluntarily offered to surrender his teaching license.
