



- 1 2. On February 16, 2011, Huber-Mayotte was convicted of Criminal Mistreatment-1 (ORS  
2 163.205), a Class C Felony, and Aggravated Theft in the 1<sup>st</sup> Degree (ORS 164.057), a Class B  
3 Felony
- 4 3. The conduct leading to Huber-Mayotte's conviction was that Huber-Mayotte defrauded  
5 approximately \$182,000 from his elderly mother. Huber-Mayotte's conduct further led to  
6 his mother being removed from his home for her own care and protection.

7 **CONCLUSIONS OF LAW**

8 Gregory Roger Huber-Mayotte's conduct described in #2 above constitutes Gross  
9 Neglect of Duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates  
10 OAR 584-020-0010(5) (*Use professional judgment*); OAR 584-020-0040(4)(o) as it  
11 incorporates OAR 584-020-0035(3)(a) (*Maintain the dignity of the profession by respecting*  
12 *and obeying the law, exemplifying personal integrity and honesty*). This conduct also  
13 constitutes Gross Unfitness in violation of ORS 342.175(1)(c); OAR 584-020-0040(5)(c)  
14 (*Conviction of violating any federal, state, or local law. A conviction includes any final*  
15 *judgment of conviction by a court whether as the result of guilty plea, no contest plea or any*  
16 *other means*).

17 Huber-Mayotte's conduct as described in #3 above, constitutes Gross Unfitness in  
18 violation of ORS 342.175(1)(c); OAR 584-020-0040(5)(e) (*Admission of or engaging in acts*  
19 *constituting criminal conduct, even in the absence of a conviction*).

20 The Commission's authority to impose discipline in this matter is based upon ORS  
21 342.175.


